CLINTON COUNTY SHERIFF

Kyle Knight was present and provided the following information:

- Seat belt grant complete.
- Deputy Clark was instrumental in the apprehension of a suspect in the Watertown Twp. homicide. He was also involved in an accident when lights and siren were a ctive.

- Arrest in B&E on Lowell Rd.
- Intoxicated subject injured in incident in village limits.

Steve Meinhardt – Casair, Inc., along with several supporters, was present to discuss placement of equipment on the water tower which would provide high speed internet for area residents. Following are some of the points covered:

- Engineering bids for the project were \$4,000 and \$2,800

Dave Freeman, Dave Fox and Mike Fitzpatrick from Westphalia Broadband were present to discuss providing phone, cable and wireless services for the village. Following are some key points:

- Wireless speed of 3 MB; 140 channel line up for cable; voicemail, caller ID and call waiting are standard with phone service
- Triple Play (cable, phone and wireless) cost is \$99.95/mo
- Cost is 15-20% less than Verizon
- Time frame for installation would be the Fall of 2008
- Dave Freeman will provide a Franchise Agreement in the next week or two

Andy Thelen was present to discuss the organization of a 5K Run on Saturday, July 26, 2008 to raise funds and awareness for Smith-Lemli-Optiz Syndrome. The route was discussed and the council pledged their support in this project.
