Sanitary Sewer O & M Fund – expense decrease \$41,900.00  
Water O & M Fund – revenue decrease \$7,400.00 and expense increase \$30,800.00. Motion carried.

Sanitary Sewer O & M Fund - revenue \$81,200.00 and expense \$124,100.00  
Water O & M Fund - revenue \$148,250.00 and expense \$118,700.00. Motion carried.
