FOWLER CODE OF ORDINANCES – AMENDMENT OF VILLAGE ZONING MAP

BOARD ACTION: Trustee Klein moved, supported by Trustee Childers, to adopt the following Zoning Map Amendment:

THE VILLAGE OF FOWLER ORDAINS:

AN ORDINANCE TO AMEND THE ZONING MAP OF THE VILLAGE OF FOWLER REFERRED TO IN CHAPTER 4, ZONING DISTRICTS AND BOUNDARIES, SECTION 4.2, OF THE VILLAGE OF FOWLER ZONING ORDINANCE, TO RECLASSIFY A SINGLE FAMILY RESIDENTIAL PARCEL TO A GENERAL COMMERCIAL PARCEL. THE ORDINANCE IS AMENDED AS FOLLOWS:

Chapter 4 ZONING DISTRICTS AND BOUNDARIES

SECTION 4.2 Zone District Map

The Zoning Map of the Village of Fowler, Michigan, is amended to reclassify the premises at 10644 East Second Street (tax parcel number 041-012-000-260-00) from a Single Family Residential parcel to a General Commercial parcel, the surveyed description of which is: Commencing 1361 feet East of the Southwest corner of Section 12, T7N-R4W, thence North to the Detroit, Grand Haven, Milwaukee Railroad, thence East along the South side of Railroad 100 feet, thence South to the South line of Section 12, thence West to the point of beginning, in the Village of Fowler, County of Clinton, State of Michigan. Motion carried.
