2022 BUDGET

BOARD ACTION: Trustee Fink moved, supported by Trustee Rhynard to close the Public Hearing since there was no public comment. Motion carried.

BOARD ACTION: Trustee Schrauben moved, supported by Trustee Humphrey, to approve the agenda as presented. Motion carried.

2021 BUDGET ADJUSTMENTS

BOARD ACTION: Trustee Fink moved, supported by Trustee Rhynard, to approve 2021 budget adjustments as follows:
General Fund – revenue increased \$83,092.00; expense increased \$122,800.00
Local Street Fund – expense decreased \$27,050.00
Major Street Fund – expense decreased \$9,400.00
Sanitary Sewer O&M Fund – revenue increased \$18,500.00; expense increased \$17,100.00
Water O & M Fund – revenue decreased \$200.00; expense decreased \$132,350.00. Motion carried.

2021 BONUSES

BOARD ACTION: Trustee Fink moved, supported by Trustee Rhynard, to award a \$2,000.00 bonus to Vern Feldpausch, Brad Smith and Rhonda Feldpausch. A \$400.00 bonus to John Rademacher and \$75.00 bonus to Mike Koenigsknecht and Napoleon Watts. Motion carried.

2022 WAGES

BOARD ACTION: Trustee Rhynard moved, supported by Trustee Schmitt, to increase Vern Feldpausch's annual wages from \$65,211.92 to \$67,168.28; Brad Smith's annual wages from \$56,052.69 to \$57,734.27; Rhonda Feldpausch's annual wages from \$49,385.82 to \$50,867.39; John Rademacher's annual wages from \$6,000.00 to \$6,300.00, Crossing Guard wages from \$20/day to \$30/day and summer help from \$14/hour to \$15/hour. Vern Feldpausch, Rhonda Feldpausch and Brad Smith will receive a 457 company match of up to \$750.00. Motion carried.

2022 BUDGET

BOARD ACTION: Trustee Schmitt moved, supported by Trustee Rhynard, to approve the following 2022 Budget:
General Fund - revenue \$602,742.00 and expense \$572,900.00
Local Street Fund - revenue \$82,600.00 and expense \$108,200.00
Major Street Fund - revenue \$99,600.00 and expense \$48,500.00
Sanitary Sewer O & M Fund - revenue \$133,600.00 and expense \$242,250.00
Water O & M Fund - revenue \$180,250.00 and expense \$134,500.00.
Motion carried.
