2022 BUDGET ADJUSTMENTS

BOARD ACTION: Trustee Fink moved, supported by Trustee Rhynard, to approve 2022 budget adjustments as follows:
General Fund – revenue increased \$41,600.00; expense decreased \$7,550.00
Local Street Fund – revenue decreased \$3,600.00; expense decreased \$11,000.00
Major Street Fund – revenue increased \$8,400.00; expense increased \$9,100.00
Sanitary Sewer O&M Fund – revenue decreased \$24,700.00; expense decreased \$99,500.00
Water O & M Fund – revenue increased \$1,250.00; expense increased \$20,700.00. Motion carried.

2022 BONUSES

There was some confusion regarding 2022 bonuses awarded at the December 13, 2022 meeting. The following action clarifies the original intent.

BOARD ACTION: Trustee Porter moved, supported by Trustee Rhynard, to award a \$1,500.00 bonus to Vern Feldpausch, Brad Smith and Rhonda Feldpausch and a \$400.00 bonus to John Rademacher. Motion carried.

General Fund - revenue \$633,350.00 and expense \$590,600.00
Local Street Fund - revenue \$84,500.00 and expense \$40,700.00
Major Street Fund - revenue \$107,500.00 and expense \$56,500.00
Sanitary Sewer O & M Fund - revenue \$111,600.00 and expense \$114,750.00
Water O & M Fund - revenue \$179,350.00 and expense \$125,500.00.
Motion carried.
