MARIJUANA LEGISLATION

Work in progress.

BOARD ACTION: Trustee Porter moved, supported by Trustee Klein, to decline the request from Michigan Trails Magazine regarding advertising. Motion carried.

BOARD ACTION: Trustee Klein moved, supported by Trustee Rhynard, to adopt Resolution #2018-03; a resolution to adopt an amendment to the Village of Fowler Zoning Ordinance which reads as follows:

RESOLUTION TO ADOPT AN AMENDMENT TO THE VILLAGE OF FOWLER ZONING

ORDINANCE PROHIBITING MARIHUANA ESTABLISHMENTS UNDER INITIATED LAW 1 OF 2018, THE MICHIGAN REGULATION AND TAXATION OF MARIHUANA ACT

WHEREAS, Public Act 3 of 1895, MCL 61.1 *et seq.*, as amended, authorizes the Village to adopt ordinances that regulate the public health, safety and general welfare of persons and property and to codify such ordinances; and

WHEREAS, on November 6, 2018, Michigan voters approved Initiated Law 1 of 2018, known as the Michigan Regulation and Taxation of Marihuana Act ("2018 Marihuana Act"); and

WHEREAS, among other things, the 2018 Marihuana Act makes marihuana legal under state and local law for adults 21 years of age or older, makes industrial hemp legal under state and local law, and controls the commercial production and distribution of marihuana under a system that licenses, regulates, and taxes the businesses involved; and

WHEREAS, Section 6 of the 2018 Marihuana Act authorizes a municipality to completely prohibit or limit the number of marihuana establishments within its boundaries. A "marihuana establishment" under the 2018 Marihuana Act means a marihuana grower, marihuana safety compliance facility, marihuana processor, marihuana microbusiness, marihuana retailer, marihuana secure transporter, or any other type of marihuana-related business licensed by the Michigan Department of Licensing and Regulatory Affairs; and

WHEREAS, the Village has considered the potential benefits, challenges, and costs of permitting marihuana establishments within its

boundaries and has determined that prohibiting marihuana establishments is in the best interest of the public health, safety, and welfare; and

WHEREAS, the Village wishes to adopt an ordinance prohibiting marihuana establishments within its boundaries.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. Pursuant to the authority granted to the Village by Public Act 3 of 1895, MCL 61.1 *et seq.*, as amended, and the Michigan Regulation and Taxation of Marihuana Act, and any other applicable statutory authority, the Council hereby adopts an amendment to the Village of Fowler Zoning Ordinance Prohibiting Marihuana Establishments Under Initiated Law 1 of 2018, the Michigan Regulation and Taxation of Marihuana Act.
- The Village Clerk is directed to prepare a supplement to the
 Village of Fowler Code of Ordinances that includes the Ordinance, attached as
 Exhibit A.
- 3. The Village Clerk, in accordance with MCL 66.4, shall publish either a true copy or a synopsis of the Ordinance once in a newspaper of general circulation in the Village within 15 days after adoption.
- 4. Any and all resolutions or parts of resolutions inconsistent with this Resolution are hereby repealed to the extent necessary to give this Resolution full force and effect.

A roll call vote on the foregoing resolution was taken and was as follows: AYES: Schrauben, Rhynard, Halfmann, Porter, V. Thelen, Fink and Klein. NAYS: None.

Motion carried.
