PLEDGE OF ALLEGIANCE AND ROLL CALL

**BOARD ACTION:** Trustee Schrauben moved, supported by Trustee Humphrey, to approve the agenda as presented. Motion carried.

2020 BUDGET ADJUSTMENTS

**BOARD ACTION:** Trustee Porter moved, supported by Trustee Rhynard, to approve 2020 budget adjustments as follows:  
General Fund – revenue decreased \$15,000.00; expense decreased \$26,800.00  
Local Street Fund – revenue decreased \$4,000.00; expense increased \$12,450.00  
Major Street Fund – expense increased \$33,000.00  
Sanitary Sewer O&M Fund – revenue increased \$36,000.00; expense decreased \$19,440.00  
Water O & M Fund – revenue increased \$45,300.00; expense increased \$3,800.00. Motion carried.

2021 WAGES

**BOARD ACTION:** Trustee Schrauben moved, supported by Trustee Humphrey, to award a \$500.00 bonus to Vern Feldpausch, Brad Smith and Rhonda Feldpausch. A \$200.00 bonus to John Rademacher and \$75.00 bonus to Mike Koenigsknecht and Mark Witgen and Roy Witgen. Motion carried.

**BOARD ACTION:** Trustee Schrauben moved, supported by Trustee Humphrey, to increase Vern Feldpausch's annual wages from \$63,933.25 to \$65,211.92; Brad Smith's annual wages from \$54,953.62 to \$56,052.69; Rhonda Feldpausch's annual wages from \$48,417.47 to \$49,385.82. Vern Feldpausch, Rhonda Feldpausch and Brad Smith will receive a 457 company match of up to \$750.00. Motion carried.

2021 BUDGET

The proposed 2021 budget was presented and reviewed. Final approval will take place after the Public Hearing scheduled on Tuesday, January 12, 2021.
