CLINTON COUNTY AMBULANCE SERVICE AND AUTHORITY

BOARD ACTION: Trustee Fink moved, supported by Trustee Porter, to approve the April 2021 to March 2022 Clinton County Ambulance Capital Budget projecting a \$53,540.00 year-end balance and the Clinton County Ambulance Service Budget projecting a \$99.00 surplus. Motion carried.

BOARD ACTION: Trustee Fink moved, supported by Trustee Humphrey, to adopt RES #2021-01 which reads as follows:

WHEREAS, the Village of Fowler is an incorporating municipality of the Clinton Area Ambulance Service Authority ("CAASA"); and

WHEREAS, CAASA has certain anticipated capital purchases/improvements for its upcoming 2021-2022 fiscal year, including, but not limited to, the "Capital Improvements"; and

WHEREAS, CAASA has an aging fleet of major equipment that is soon to be obsolete and no longer usable including cots, monitors, etc.; and

WHEREAS, pursuant to Article XVI ("Financing the Authority") and Article XVIII ("Capital Improvements") of CAASA's Articles of Incorporation, incorporating municipalities may provide funding for CAASA's capital purchases/improvements, in amounts greater than each incorporating municipality's financial contribution as provided for in Article XVI, Paragraph A of CAASA's Articles of Incorporation, if such additional funding is approved by the affirmative vote by resolution of each municipal board of all incorporating municipalities; and

WHEREAS, the above named municipality desires to approve such additional funding for CAASA's anticipated Capital Improvements at the rate of \$6.00 per capita based on their municipality's population, for CAASA's 2021-2022 fiscal year only.

WHEREAS, the above named municipality desires to approve such additional funding for CAASA's equipment replacement fund at a flat rate of \$1,000.00 for CAASA's 2021-2022 fiscal year only.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Village of Fowler hereby approves the above funding for CAASA's 2021-2022 fiscal year only,

2. The Village of Fowler approval of additional funding for CAASA's anticipated Capital Improvements, as provided herein, is voluntary.

3. The Village of Fowler also approves of the voluntary additional funding for CAASA's equipment replacement fund, as provided herein, and is to be applied towards the purchase of major equipment expenses such as cots, monitors, etc.

4. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be, and the same are, hereby rescinded. ROLL CALL

Whereas: The Village of Fowler is a municipality which is a member of the Clinton Area Ambulance Service Authority (hereafter referred as CAASA); and Whereas: Each member municipality contributes \$3.00 per capita for capital expenses/improvements including the acquisition of new ambulances; and Whereas: CAASA intends to purchase one (1) ambulance and related equipment (the "Property") from Kodiak Emergency Vehicles, Grand Ledge, Michigan, in an amount not to exceed One Hundred Thirty Thousand Dollars (\$130,000), and to enter into an installment purchase agreement (the "Installment Purchase Agreement") to finance a portion of the cost of the Property; and

	 Whereas: The CAASA Board has received an offer from Mercantile Bank (the "Bank") to finance One Hundred Thousand Dollars (\$100,000) through an Installment Purchase Agreement at an interest rate not to exceed three percent (2.65%) per annum over a period not to exceed 2 years, with monthly principal and interest payments beginning no later than thirty (30) days after the date of funding/closing, with monthly interest thereon, based upon a 360-day year, 30-day month, and the Board now desires to accept that offer; and Whereas: The Articles of Incorporation of CAASA requires that all member municipalities approve by resolution in approval for CAASA to seek financing for such an acquisition/capital expense. Now Therefore, be it resolved that the Village of Fowler does hereby approve of CAASA to enter into an Installment Purchase Agreement in order to finance the purchase of the Property described above. The cost to add a vessel to the plant, necessitated by increased water usage; in 2021 is approximately \$500,000.
