CLINTON AREA AMBULANCE RESOLUTION

BOARD ACTION: Trustee Porter moved, supported by Trustee Schrauben, to approve cement saw purchase of \$1944 and water main saw purchase of \$1760. Motion carried.

BOARD ACTION: Trustee Fink moved, supported by Trustee Humphrey, to adopt Resolution #2020-03, a resolution to approve additional funding for Clinton Area Ambulance Service Authority which reads as follows:

WHEREAS, the Village of Fowler is an incorporating municipality of the Clinton Area Ambulance Service Authority ("CAASA); and

WHEREAS, CAASA has certain anticipated capital purchases/improvements for its upcoming 2020-2021 fiscal year, including but not limited to the "Capital Improvements"; and

WHEREAS, pursuant to Article XVI (Financing the Authority") and Article XVII ("Capital Improvements© of CAASA's Articles of Incorporation, incorporating municipalities may provide funding for CAASA's capital purchases/improvements, in amounts greater than each incorporating municipality's financial contribution as provided for in Article XVI, paragraph A of CAASA's Articles of Incorporation, if such additional funding is approved by the affirmative vote by resolution of each municipal board of all incorporating municipalities; and

WHEREAS, the Village of Fowler desires to approve such additional funding for CAASA's anticipated Capital Improvements at the rate of \$3.00 per capita based on the Village of Fowler's population, for CAASA's 2020-2021 fiscal year only.

NOW, THEREFORE, BE IT RESOLVED THAT:

- The Village of Fowler hereby approves additional funding for CAASA's anticipated Capital Improvements at the rate of \$3.00 per capita based on the Village of Fowler's population, for CAASA's 2020-2021 fiscal year only.
- The Village of Fowler's approval of additional funding for CAASA's
 anticipated Capital Improvements, as provided herein, is contingent on the
 approval of such additional funding by the affirmative vote by resolution of
 each municipal board of all CAASA's incorporating municipalities.
- 3. All resolutions and parts of resolution insofar as they conflict with the provisions of this resolution be, and the same are, hereby rescinded.

REDEVELOPMENT READY COMMUNITY RESOLUTION

BOARD ACTION: Trustee Humphrey moved, supported by Trustee Fink supported, to adopt Resolution #2020-02 regarding participation in MEDC Redevelopment Ready Community which reads as follows:

WHEREAS, the Michigan Economic Development Corporation (MEDC) has established the statewide Redevelopment Ready Communities (RRC) Program to empower communities to shape their future and maximize economic potential; and

WHEREAS, RRC is a program that provides technical assistance to and certifies Michigan communities who actively engage stakeholders and plan deliberate, fair, and consistent processes; and

WHEREAS, Village of Fowler staff has taken Redevelopment Ready training; and

WHEREAS, the RRC program is now a component for grant applications through the MEDC and Michigan State Housing Development Authority; and

WHEREAS, the Village of Fowler recognizes the value of the RRC Program and seeks to improve its development readiness via a detailed review of its development processes, including its Comprehensive Master Plan, Downtown Development Plan and Zoning Ordinances; and

WHEREAS, the RRC Certification is a multi-year process. The pace of adoption of best practices will be based on the Village's capacity and therefore no deadline is established.

NOW THEREFORE BE IT RESOLVED, the Village of Fowler Village Council hereby authorizes the Village of Fowler to participate in the Michigan Economic Development Corporation's Redevelopment Ready Community Program. The Village of Fowler hereby commits to the RRC Best Practices and evaluation process and that will lead to further development in our community for the benefit of all.
