CONSUMERS ENERGY GAS FRANCHISE ORDINANCE

BOARD ACTION: Trustee Fink moved, supported by Trustee Humphrey, to adopt Ordinance No. 55. An ordinance, granting to Consumers Energy Company, its successors and assigns, the right and authority to lay, maintain and commercially operate gas lines and facilities including but not limited to mains, pipes, services and on, under, along, and across public places including but not limited to highways, streets, alleys, bridges, and waterways, and to conduct a local gas business in the Village of Fowler, Clinton County, Michigan for a period of thirty years. Motion carried.

CLINTON COUNTY SOLID WASTE AMENDMENTS

BOARD ACTION: Trustee Fink moved, supported by Trustee Schrauben, to adopt resolution #RES-2023-04 which reads as follows:

WHEREAS Clinton County ("County") has adopted a Solid Waste Management Plan ("Plan") under the authority of 1994 PA 451, Part 115 ("Part 115") as amended; and WHEREAS Part 115 requires the Plan to be periodically updated in light of changing circumstances; and

WHEREAS, on August 29, 2023, the Clinton County Board of Commissioners adopted a Plan Amendment in Resolution 2023-16; and

WHEREAS Part 115 requires review and approval of the Plan Amendment by at least 67% of the municipalities located within Clinton County; and

WHEREAS, the Village of Fowler has reviewed the Plan Amendment and finds that it promotes and protects the solid waste needs and interests of the citizens living therein;

NOW, THEREFORE, BE IT RESOLVED that the Village of Fowler approves the proposed Plan Amendment to the Clinton County Solid Waste Management Plan.

BE IT FURTHER RESOLVED that a copy of this resolution shall be forwarded to the Clinton County Department of Waste Management at 100 East State Street, Suite 1500, St. Johns, MI 48879 and may be included as a matter of record in the Appendix of the Solid Waste Management Plan or its Plan Amendment.

ZONING AMENDMENT: CHAPTER 3

BOARD ACTION: Trustee Humphrey moved, supported by Trustee Rhynard, to adopt the following Zoning Amendment:

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE VILLAGE OF FOWLER REGARDING MAXIMUM LOT COVERAGE UNDER CHAPTER 3; SECTION 3.2.B.2, THE ORDINANCE IS AMENDED AS FOLLOWS:

Chapter 3 SECTION 3.2 ACCESSORY BUILDINGS AND STRUCTURES

B. Detached Accessory Buildings and Structures – Residential Districts or Uses
 2. The lot coverage shall not exceed the maximum lot coverage as noted within each Zoning Ordinance section for all principal and accessory buildings on a parcel.

DAVE POHL – CLINTON COUNTY COMMISSIONER

Dave Pohl – Clinton County Commissioner sent correspondence outlining the following issues:

- Clinton County was just notified that subject to a comment period by other broadband providers that we were successful with a Broadband grant for part of the proposed project.
- The BoC approved an ordinance allowing ORV on certain County Roads.
- Clinton County approved a letter of commitment for participation with Ingham and Eaton to apply for an EPA grant to support Regional Brownfield Redevelopment.
- The County Board approved a Youth Outreach program offered by (Community Mental Health) CMH to get involved with youth who seem to be struggling with stress, anger or other emotional issues. This is a preventative effort and it also engages the parents or guardians.
- The BoC approved the Waste Management requested renewal of the Rural Recycling program for 2024.
- The Clinton County Township Officers Assn. will be holding their November meeting at the new Road Commission facility and will include a public tour from 4 to 6 facilities on November 21st. Will be a ribbon cutting. The meeting will follow at 7 pm. Mark your calendar.
